

**-: Note :-**

The term "**Family**" defined in the CCS(LTC) Rules, 1989 as under:

"Family" means: -

- a) the Government servant's wife or husband, as the case may be, and two surviving unmarried children or stepchildren wholly dependent on the Government servant, irrespective of whether they are residing with the Government servant or not;
- b) married daughters who have been divorced, abandoned or separated from their husbands and widowed daughters and are residing with the Government servant and are wholly dependent on the Government servant;
- c) parents and/or stepparents (stepmother and stepfather) who are wholly dependent on the Govt. employees, irrespective of whether they are residing with the Government employee or not.
- d) unmarried minor brothers as well as unmarried, divorced, abandoned, separated from their husbands or widowed sisters residing with and wholly dependent on the Government servant, provided their parents are either not alive or are themselves wholly dependent on the Government servant.

Further, the term "**wholly dependent**" defined as under:

"A member of family whose income from all sources, including pension, temporary increase in pension does not exceed minimum pension (presently Rs. 9000/- per month as per 7<sup>th</sup> CPC) and Dearness relief (DR) thereon, is deemed to be wholly dependent on the Government employee."
